## Minutes From July Meeting

*President Mark Tennant called the meeting to order on or about 9:30 am, July 12, 2015 in the Federal Camp at Rich Mountain.*

*Approximately 20 members were present.*

*Mark Tennant suggested that the reading of the minutes from the last meeting be waived. Chuck Critchfield stated that he felt a correction of the minutes was in order. The minutes from the June meeting read: "Tim Glaser gave Treasurer's report balance of \$3,500 including \$1,500.00 Droop grant." That should be corrected to read "Tim Glaser gave Treasurer's report balance of about \$3,500 not including \$1,500 Droop grant." No objection having been raised to the correction, it is entered into the records.*

## **WALKING IN ANCESTORS SHOES**

When I first heard about the Grand Review last year while attending New Market reenactment, I thought how cool it would be to march down Pennsylvania Ave. After signing up for march, I started doing a little research to see what West Virginia regiments actually participated in 1865 Grand Review. The 7th West Virginia Infantry, one of the premiere West Virginia Infantry regiments and only one in the Army of the Potomac was present. My great-great Grandfather Amos Hoffman had been drafted into the Union Army and was mustered in on April 9, 1865 (the day Lee surrendered) into the 7th WV Inf. as a private. But by May 1st he was promoted to Corporal and marched in the Grand Review later that month in Washington D.C. Amos had served with the Marion County Union militia prior to being drafted into the 7th. After the war, Amos was a successful farmer. Family tradition say he applied for and got a pension later but when he received the government check they had

misspelled his name from Hoffman to Huffman. To prevent any problems cashing the checks, he just went along and changed his name to Huffman. He is buried in the Mt. Nebo church cemetery on Bunner's Ridge in Marion Co.
