## 155 Years Ago

### 1<sup>st</sup> (West) Virginia Infantry

December, 1861 and the first winter of the war is underway.

C. J. Rawlins describes the garrison duty that the 1<sup>st</sup> was performing in December as “rather monotonous life....interrupted occasionally by alarms of the enemy’s appearance.”

Being on the front lines the Confederates were not far away and keeping constant watch on the 5 or 6 regiments then occupying Romney. During December Lieutenants Freeman were captured while on picket.

In December of 1861, Joshua Winter’s letters to his sister describe a little excursion that his company (G) and Company H made three miles from camp. Once they arrive at the picket post, word came that a skirmish was underway at “French town” (present day Frenchburg located on Route 50 between

Romney and Augusta). The two companies quickly marched in that direction at the “dobble kick” step. Winters claims they marched 3 miles in 17 minutes to reach French town only to find “the fun was over.”

Later, “our Lieutenant and 18 of us went on a scout to miles (2 miles) on the other side of French town” where they found no Rebels but did find chickens “in the fence corner” and milk in the “celar.”

By the fall of 1861 was well established as a staging area for horses, mules, equipment and provisions needed for United States forces facing Secessionist forces in the mountains to the east. As troops radiated eastward and southward, Clarksburg remained hub at the center of the garrisons and forces at Beverly, Buckhannon, Weston and Sutton.

During the fall, William Rosecrans had left a skeleton force to guard all these supplies leading loyal citizens to become very jittery. In September word came that Rebels had taken possession of Worthington, between Fairmont and Clarksburg, where they threatened to burn the town and move on Shinnston next. A force was quickly assembled and sent from Wheeling and Grafton to retake Worthington, only to find a half-dozen drunken rebels had entered the town, torn down the American flag and threatened to burn the town. This large force fled before the Federal force sent to subdue them could arrive.
