Bill Brisendine\* had to work and John Brasuk\* was unable to attend. The 25<sup>th</sup> Virginia and Artillery representative positions are vacant at this time but both have nominations for 2017.

1. Discussed Chris Johnson's resignation. Chris warned by email that the 25<sup>th</sup> is about to lose their membership in the ANV due to lack of participation in events.
2. On a side note, John Brasuk bought JR Moores's cannon and Kelso Marple's cannon may also be for sale.
3. John Brasuk had proposed to Chuck to be the unit rep for both the Calvary and the Artillery. The bylaws limit only one office per person. Sam Krafft expressed interest to Chuck to be the unit rep for the Artillery 2017. The board tentatively assigned John to the Calvary and Sam to the Artillery. This can be changed at the next meeting.
4. Future of the WVRA  
In 2016 there were approximately 75 members and so far for 2017, 35 members have signed up.

We can continue as is. We need volunteers for president and vice president. Need to get more involvement for events.

After the success of the Historic Beverly Time Line event this summer, it was proposed to open up membership to other time periods. It would be good to have a state wide umbrella reenactment group.

To our knowledge the French and Indian reenactment groups do not have a higher level organization. Need to talk to Karl Mulac in Beverly, WV, about this assumption. Jim Barnes is a member of several WWII units. He will talk to some of these reenactors and will report back to our group about their interest in joining the WVRA.

Chuck asked if membership will be limited to groups from periods of American history. This seemed to be the consensus of the board. The only objection to opening up membership was by Mark not wanting SS or Gestapo Units to be members.

Preliminary review of the Bylaws indicates that not a lot of changes will need to be made.

## NEXT MEETING

The annual meeting is scheduled for Saturday, January 7 at 1 pm at the steak house at exit 99 of I-79 near Weston.

At the annual meeting we will be voting on officers, both administrative and military officers for 2017. Some nominations have been made to date (see below) but members may nominate from the floor.

To date we have received no nominations for president and vice-president and only the 1<sup>st</sup> West Virginia has nominations for military officers.

Also, it is expected, that further discussion of the WVRA's future will take place. That would include further talk about including other historical periods in the WVRA.
